











## SAFER AND CLEANER USED VEHICLES FOR AFRICA

25 June 2021

## Background

Most African countries rely on used vehicle imports to meet increasing mobility needs. Used vehicles therefore play an important role in promoting cleaner and safer mobility in Africa. However, without minimum standards and regulations to incentivize import of cleaner and safer vehicles, used vehicles can be a leading contributor to both global climate emissions and local air pollution, and increased road accidents.

Two reports by UNEP<sup>1</sup> and the Netherlands Government<sup>2</sup> launched last year show that most African countries lack minimum regulatory standards to attract cleaner and safer cars, but also that countries that had such minimum standards were able to attract cleaner, safer used vehicles.

## Safer and Cleaner Used Vehicles for Africa

In response to the need for safer and cleaner used vehicles import into Africa, and building on on-going initiatives, the <u>UN Road Safety Trust Fund</u> is promoting minimum used vehicles standards in Africa. The partners implementing this initiative are UN Environment Programme (UNEP), UN Economic Commission for Europe (UNECE), Federation Internationale d'Automobile (FIA), International Motor Vehicles Inspection Commission (AUC). The phase 1 of the project focuses on two sub-regions, the Economic Community of West African States (ECOWAS) and the East African Community (EAC) to develop and implement minimum cleaner, safer vehicle regulations and is expected to expand to the other African regions later. The implementing partners are at the same time engaging with the three main used vehicles exporting countries/regions - European Union, Japan and USA – to agree to a minimum criterion before export of used vehicles.

## **First African Used Vehicles Importers Meeting**

This first African used vehicles importers virtual meeting targets government agencies responsible for used vehicles management, regional economic bodies that are responsible for harmonization of vehicle standards, private sector and civil society involved in used vehicle import and public outreach. The aim of the meeting is to:

- Bring the key stakeholders together to discuss the need for used vehicles regulation in the region;
- Share sub-regional and national experiences and best practices in regulating for safer and cleaner used vehicles.
