









## Number of Vehicles in Mauritius

## Overview of the Ministry of Commerce and Consumer Protection

 The Ministry of Commerce and Consumer Protection is responsible for matters related to international trade practices and the implementation of trade policies. It is concerned with the control of Import and Export of certain Controlled/ Restricted goods while also ensuring that there is smooth exchange of goods and services at national and international levels and regular supply of essential commodities. Apart from warranting a conducive commercial environment, it also aims to have an effective protection of consumers.

## Importation of second-hand motor vehicles

- The importation of second-hand motor vehicles falls under the aegis of the Ministry of Commerce and Consumer Protection.
- The imports of second-hand motor vehicles are regulated by the Consumer Protection (Control of Imports) Regulations 2017 [GN 160 of 2017].


## The Consumer Protection (Control of Imports) Regulations 2017

- No person shall import any vehicle unless he holds an import permit.
- An import permit shall
  - a) be valid for a period of 12 months
  - b) not be transferable
  - c) relate to the restricted goods specified in the permit; and
  - d) be subject to such terms and conditions as the Permanent Secretary may impose.
- Prior to the importation of second-hand motor vehicles, an application for an import permit has to be made on the Tradelink System (Single window system).

## Tradelink System (Single window system)

- It is an electronic platform for the online application, processing and issue of permits and trade related clearances.
- The objectives of the Single Window System are to:
  - a. provide an electronic platform for the application, processing and approval of import and export permits;
  - b. enable operators to track progress of the status of their applications;
  - c. enhance the trade efficiency through reduction of processing time and related transaction costs;
  - d. improve trade facilitation and providing a one-stop shop service to operators, traders as well as customers; and
  - e. accelerate trade liberalisation, elimination of non-tariff barriers and the ease of doing business.

## **Exempted Importers**

- Embassies and their personnel
- 2. Foreigner who is
  - a. taking employment in Mauritius;
  - b. an investor, a self-employed non-citizen or a professional who has been granted an occupational permit for 3 years or more under section 9A of the Immigration Act;
  - c. a retired non-citizen who has been granted a residence permit under section 9B of the Immigration Act; or
  - d. a holder of immovable property under the Integrated Resort Scheme who has been granted a residence permit under section 5(1)(g) of the Immigration Act,

importing a motor car for his own use from abroad without any transfer of funds from Mauritius

## Exempted Importers (Ctd)

- 3. Foreign firm engaged in a Government project or any other project of national interest importing its own vehicles, from abroad, involving no transfer of funds from Mauritius
- 4. Government bodies, local authorities, parastatal bodies
- 5. Religious, educational and benevolent institutions receiving a secondhand motor vehicle from abroad involving no transfer of funds from Mauritius
- 6. Returning resident or spouse of a returning resident or a Mauritian receiving as gift a second-hand motor vehicle owned by his father, mother, brother, sister, son or daughter staying abroad, without any transfer of funds from Mauritius

## **Authorised Dealers**

- Authorised dealers are those companies who have been issued with a Licence as authorised dealers in importation and sale of second hand motor-vehicles.
- Authorised dealers should hold a business premises consisting of a showroom or closed yard, or both and an office which shall be
  - a. Destined solely for the display and sale of imported second-hand motor vehicles and sale of spare parts
  - b. Separated from any other compound or building used for a purpose, other than for the purposes specified under paragraph (a); and
  - c. Easily accessible to the public and motor vehicles
- Authorised dealers are required to provide to the Ministry an insurance security or a bank guarantee of Rs 5 million per showroom for 2 years as from the date of license.
- All authorized dealer should provide a warranty period of at least 1 year to the consumer as a way of ensuring that the vehicle is in good running conditions.

## Mandatory Criteria for Authorised Dealers to meet

- When importing from all countries
  - i. Pre-Shipment Certificate
  - ii. Age Criteria
  - iii. Vehicle should not be reported as stolen

### Criteria for Authorised Dealers to meet (Ctd)

- When importing from Africa
  - Together with the criteria mentioned above, a Sarpcco certificate is required.
    - The commissioner of Police of Mauritius has a common database with Africa, which enables them to check whether the vehicle has been stolen or not.

# Procedures prior to shipping of the second-hand motor vehicles

- Authorised dealers shall submit:
  - 1. A proforma invoice which includes the following:
    - Basic information about the motor vehicle
    - Chassis Number
    - Engine Number
    - Make and Model
    - Color of the motor vehicle
    - Year of Manufacture
    - Year of Registration
    - Country of Origin




# Procedures prior to shipping of the second-hand motor vehicle (Ctd)

- Authorised dealers shall submit:
  - 2. Registration Document
- **Note:** Given that Japan does not use Registration Document, the auction sheet should be submitted when importing from Japan at the time of an application for import permit is made.
- After successfully submitting those documents, the Ministry of Commerce and Consumer Protection approves the permit and the vehicle is authorized to be shipped.

## Procedures for clearance

- To be granted clearance, Authorised Dealers shall make another application on the Tradelink system to submit:
  - Export certificate
  - Pre-shipment certificate
  - Auction sheet (if Japan)

## Auction sheet



## Competent Authority

#### • Means:

- a. an overseas branch of Bureau Veritas or Société Générale de Surveillance;
- b. an authority in the exporting country recognized by the Permanent Secretary; or
- c. with regard to Japan, South Africa and the United Kingdom, an authority specified in the Ninth Schedule,

### which -

- submits a yearly bank guarantee of USD 100,000, in favour of the Government of Mauritius, to the Permanent Secretary;
- 2. gives an undertaking to the Permanent Secretary that it will only issue inspection certificates which contain true and correct information; and
- 3. abides by such conditions as the Permanent Secretary may determine.

## Inspection Certificate

- The inspection certificate shall emanate from a competent authority recognised by the Permanent Secretary and shall certify –
  - i. that the vehicle has been inspected not earlier than 2 months before the date of shipment;
  - ii. that the vehicle is not stolen;
  - iii. the roadworthiness and usability of the vehicle; and
  - iv. where the vehicle is imported from Japan, the auction grade of that vehicle.

The pre-shipment certificate should be according to the format found in the Eight Schedule of the Consumer Protection (Control of Imports) Regulations 2017

## Penalty fees

- Any person who submits an inspection certificate containing false or misleading information shall commit an offence and shall, on conviction be liable to a fine not exceeding Rs 100,000 and to imprisonment for a term not exceeding 3 years
- The permanent secretary may cease to recognize an authority as a competent authority where that authority had issued an inspection certificate containing false and misleading information.

## Penalty fees (Ctd)

- Where the holder of an import permit fails to furnish an inspection certificate, the Permanent Secretary shall grant clearance subject to –
  - i. the payment of a fee of 20,000 rupees to the Director-General;
  - ii. the vehicle being inspected by the local branch of Bureau Veritas or Société Générale de Surveillance, or by any local inspection body acceptable to the Permanent Secretary; and
  - iii. the submission of an inspection certificate in the form set out in the Eighth Schedule

## Procedures for obtaining clearance

- After verifying all the documents, the Ministry of Commerce and Consumer Protection would give clearance to the importer.
- The debarkation process can then be done.
- For the purpose of granting clearance, the Permanent Secretary or Director-General, as the case may be, may, in the absence of the scanned copy of the original invoice and the relevant shipping documents, accept
  - a. a scanned copy of the original Bill of Lading or Airway Bill or the Postal Receipt or Notice of Arrival of goods issued by an organisation providing a courier service or such other document acceptable to him; or
  - b. a scanned copy of the original Customs Provisional Bill of Entry and final Customs Bill of Entry
- The fees payable to the Permanent Secretary or Director General, as the case may be, under these regulations shall be paid electronically through the TradeNet

### Procedures for obtaining clearance (Ctd)

- After the debarkation process, the Mauritius Revenue Authority have bonded showrooms where authorized dealers can keep their vehicles against payment of prescribed fees.
- Otherwise, the authorized dealers may pay the excise duties and remove the vehicle from the bonded showroom.





### Enforcement

- The officers of Trade Division of the Ministry of Commerce and Consumer Protection does regular checks/visits to showrooms of authorized dealers to check if vehicles are affixed with:
  - The auction sheet and the pre-shipment inspection certificate of the vehicle on the windscreen of that vehicle; and
  - An explanatory note specifying the grade as per the auction sheet of that vehicle

# Sales Agreement between Authorized Dealer and a Purchaser

- An authorized dealer should sell and deliver an imported second-hand motor vehicle to the purchaser as per the sales agreement in the 5<sup>th</sup> Schedule of the Consumer Protection (Importation and Sale of Second hand Motor Vehicles) Regulations 2004.
- The purchaser is allowed by the authorized dealer to effect a test drive.
- The purchaser should also have the opportunity to take cognizance of the pre-shipment inspection certificate issued in the exporting country in respect of the second-hand motor vehicle.

## Warranty

- The authorised dealer shall guarantee the vehicle and parts for a warranty period of at least 1 year from the date of this agreement;
- The warranty covers the repairing or replacement free of charge, including labour costs, of any part that is faulty and supply of materials needed to carry out the repairs under warranty;
- The authorised dealer shall guarantee that he owns, or is affiliated to, a garage through a written agreement to provide for repairs and after sales service, especially during the warranty period.

## Inspection of Second-hand Motor Vehicles at Vehicle Examination Centers

- Prior to their registration, second-hand imported vehicles are examined at the Port Area by National Land Transport Authority Vehicle Examiners or they are taken to the Vehicle Examination Stations with a view to obtaining a Particulars of Motor Vehicle Form. The following documents will have to be produced:
  - a. Bill of Entry of the vehicle.
  - b. Certificate of registration/deregistration from the country of origin (second hand/reconditioned vehicles).
  - c. Original log book (if available)
  - d. Pre-shipment certificate from country of original
  - e. Either a removal permit or a TP.

## Inspection of Second-hand Motor Vehicles at Vehicle Examination Centers


#### **Vehicle Examination Process**

- The following tests are done at the Vehicle Examination Centre:
  - i. Visual Test
  - ii. Smoke/vehicle Emission Test
  - iii. Side Slip Test
  - iv. Shock Absorber Bounce Test
  - v. Brake Efficiency Test
  - vi. Under Carriage Inspection
  - vii. Headlight Test
- In event the second-hand vehicle complies with the Road Traffic Act, the particulars of the vehicle form and certificate of fitness are issued for registration purposes.


#### Vehicle Examination Process –Visual Test




## Vehicle Examination Process – Vehicle Emission/Smoke Test




## Vehicle Examination Process - Side Slip Test




### Vehicle Examination Process - Brake Test

## Consumer Affairs Unit (CAU)

- A consumer can make a valid complaint if he believes that his vehicle has been altered, to the Consumer Affairs unit of the Ministry of Commerce and Consumer Protection, which will do an investigation.
- The Consumer Affairs Unit (CAU) is a specialized unit within the Ministry of Commerce and Consumer Protection, which caters for the protection of consumers in general
- The main objectives of the CAU are:
  - To protect consumers through enforcement of laws
  - To educate consumers of their rights and responsibilities
  - To settle disputes between traders and consumers by mutual agreement or in case of deadlock through a court of justice
  - To update existing laws to meet the new challenges ahead

## Prohibited goods

- To ensure the safety of consumers, under prohibited goods at import, spare parts and accessories of second-hand motor vehicles listed below cannot be imported:
  - a. ball joints;
  - b. bearings;
  - c. belts;
  - d. body shells of motor cars or any parts of motor cars originally welded by the manufacturer to their structured body shells or chassis;
  - e. brake linings;
  - f. chassis and parts thereof
  - g. clutch nut and parts thereof;
  - h. coil spring, leaf spring and torsion bar;
  - i. engine mountings;
  - j. filters;
  - k. Hoses, ... etc
