







Regional Training on Inspection and Monitoring Framework for Used Vehicles Imported in the East Africa Community (EAC) Sub Region and Used Vehicles Importers and Exporters Meeting 30 August – 01 September 2022 Park Inn by Radisson

CONCEPT NOTE

Kigali, Rwanda (Hybrid)

1. Background

The East Africa Community (EAC) sub region, like other sub regions in Africa, is facing rapid vehicle growth despite having a relatively low vehicle population (number of vehicles per thousand people). Urban air pollution also continues to worsen with the growth in population and concurrent increase in demand for mobility. The sub-region majorly relies on used vehicle imports as the automotive manufacturing capacity is still in its infancy. This presents an opportunity for countries in the sub region to introduce appropriate policies to allow for import of safer, cleaner, and more fuel-efficient vehicles. This is important as the global vehicle fleet is set to triple by 2050, with over 90% of this growth taking place in developing and transitional countries. Used vehicles thus play a major role in promoting cleaner and safer mobility in Africa, and particularly in the EAC region, as most African countries rely on used vehicle imports to meet increasing mobility needs.

The importance of motor vehicles in the transportation sector is crucial, due to their major economic, political, and social benefits, which are key when considered as a means of inclusion by providing access to work, health education and other public services. It is important that vehicles are kept in environmentally friendly and safe conditions as they have a direct and indirect ability to affect different sectors of an economy. However, without minimum standards and regulations to incentivize import of cleaner and safer vehicles, used vehicles can be a leading contributor to not only climate emissions and air pollution but also increased road accidents and fatalities.

In July 2022, the East Africa Community published a gazette notice which brought to affect the first edition of EAS 1047:2022 standards on Air Quality – Vehicular exhaust emission limits. This East African Standard specifies permissible limits for common pollutants found in exhaust emissions of motor vehicles, namely carbon monoxide (CO), particulate matter (PM), oxides of nitrogen (NOX) and hydrocarbons. The standard covers emissions for new, imported used and in-use vehicles of all types of motor vehicles with internal combustion engines namely, passenger cars, light commercial vehicles, heavy-duty vehicles, motorcycles, and motor tricycles.

Vehicle exhaust emissions of newly registered vehicles (both new and used imports) in the Partner States will be required to comply to a minimum of Euro 4/IV equivalent vehicle emissions standards. After gazettement of the standards, Partner States have up to 6 months to implement the standard. Within this timeline, the Partner States will need to prepare thorough awareness raising and sensitization.

In addition, the African continent suffers the highest road fatalities due to the import of poor-quality used vehicles, among other reasons. The "Safer and Cleaner Used Vehicles for Africa project" that is funded by the UN Road Safety Trust Fund and was launched in 2020 with UNEP, UNECE, UNECA, AUC CITA and FIA as the main project implementing partners (see https://www.unep.org/explore-topics/transport/what-we-do/regulating-used-vehicles). The project objective is to work with both exporting and importing countries to develop a set of standards and incentives that will ensure only









vehicles that meet minimum safety and environment standards will be allowed into African countries. This includes the establishment of used vehicle information sharing systems with data support, inspection and monitoring frameworks and implementation of compliance systems, complemented by capacity building through trainings on various key topics. Regional bodies in Africa like ECOWAS and EAC have taken positive steps to establish and harmonize regional standards to regulate the import of used vehicles. On the other hand, regional bodies in the exporting regions like the EU are also taking steps to review important legislative tools that could have a positive impact on the quality of used vehicles exported. These elements form the basis of the three-day meeting.

2. Objectives of the Meeting

The 2-day training will be geared to supporting capacity building on the importation of cleaner and safer used vehicles within the East Africa (EAC) sub region including sharing best practices regarding inspection, monitoring framework and compliance systems.

The one-day exporters – importers meeting will seek to engage used vehicle importers/exporters in discussions on key elements of minimum requirements for the transfer of quality used vehicles from exporting to importing countries.

3. Modalities of the meeting

The training will be hybrid (in-person and online) and will run from 30 August – 01 September 2022. Two days will be dedicated to a regional training on used vehicles inspection, monitoring, and compliance system, and how to regulate import and in-use vehicles to ensure they meet minimum emissions and safety requirements, advocate for presentations on ongoing used vehicles initiatives on the continent and road safety issues.

The EAC Secretariat will present the regionally harmonised standard and proposals on guidelines for the importation of safer and cleaner vehicles. The experience of Rwanda as one of the two countries in the sub region to implement standards on vehicle exhaust emission limits will be shared to draw lessons that could be used in the other countries. Country representatives will share country status towards implementing the harmonized standards and make contributions to the proposed regional guidelines on import of cleaner and safer vehicles.

The last day will be dedicated to engaging with importers and exporters of used vehicles on minimum requirements for quality used vehicles. UNECE has worked on a summarized document which includes selected minimum standards for environment and safety that will be shared at the meeting. Importer and exporter responsibilities will also be elucidated in the meeting.

4. Expected participants

Thirty-Five participants from EAC Partner States, UNEP, UNECE partners, and the EAC Secretariat are expected to participate in person. A virtual link will be availed to enable participation from other stakeholders.

Funding

UNEP (through its partners) and UNECE will provide a return air ticket and lumpsum allowance to cater for accommodation and meals, in accordance with its terms and conditions, for participation of delegates from the Partner States and EAC Secretariat staff. UNEP/UNECE will also provide conference









facilities for all the participants. Partner States may support their own additional delegates to benefit from the awareness.

5. Expected results

The main results expected from this meeting are:

- 1. Sub regional sensitization and capacity building materials on minimum criteria for importation and enforcement of cleaner and safer used vehicles.
- 2. Final report on capacity building and enforcement of cleaner and safer used vehicles importation in the East Africa Community (EAC).
- 3. Agreed set of minimum criteria that can be validated at point of shipment and destination to verify used vehicles are safe and environmentally friendly for import/export.
